Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and account balances Payment history and transaction history Credit history and credit scores When you are no longer our member, we continue to share information as described in this notice. 		
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Arrowhead Credit Union chooses to share; and whether you can limit this sharing.

Definitions				
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.			
	 Arrowhead Credit Union has no affiliates. 			
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.			
	 Companies not owned by Arrowhead Credit Union that are contracted to provide member services. Nonaffiliates we share with can include mortgage companies and insurance providers. 			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.			
	 Our joint marketing partners include investment companies and insurance providers. 			

*California state law gives you additional rights to limit information sharing with our joint marketing partners even if such sharing is otherwise permitted under federal law. Please read the enclosed form entitled "Important Privacy Choice for Consumers" which includes details on how you can limit our information sharing under California law.

If you have previously opted-out and would like to keep the same preference, you do not need to opt-out again.
